\_\_\_\_ The Horse is in good health and free of communicable diseases at the present time. **Turning Point**



has 30 days from the delivery date to have the Horse examined by a licensed veterinarian (Turning Point will pay all veterinarian fees). If the Horse fails the examination, **Turning Point**, with a written statement from the veterinarian, may return the Horse to the Owner.

**In Addition**

\_\_\_\_ **Turning Point** will evaluate the Horse for use in a Therapeutic Riding Program for a period not to exceed 60 days. At **Turning Point**, the Horse will be ridden by individuals with physical, mental or emotional challenges, surrounded by sidewalkers and in an arena with up to five other horses where a variety of activities, toys, and loud noises are the norm. **Turning Point** horses are not used more than three sessions per day. Our horses are kept in a pasture, with clean water and hay available. In addition, they are fed at least once a day.

\_\_\_\_ During the trial period and period of service, decisions regarding and the cost of all feed, medication, veterinary care or farrier services will be assumed by **Turning Point**. If the Horse proves unsuitable during the trial, it will be returned to the Owner.

\_\_\_\_ During the trial period and period of service, Owner must contact **Turning Point** and make appointment in order to visit, use (as written in Additional Provisions), or move the Horse for any reason.

**INDEMNITIES:**

**Turning Point** will indemnify and hold harmless the Owner for any accidents or injuries that might result from his use during the trial period and subsequent service with our program. The Owner will indemnify and hold harmless **Turning Point** in the event of injury or death of the Horse during the trial period or subsequent service to the program.

**BINDING EFFECT:** The covenants and conditions contained in this contract shall apply to and bind the parties and the heirs, legal representatives, successors and permitted assigns.

**SEVERABILITY:** If any part or parts of this contract shall be held unenforceable for any reason, the remainder of this contract shall continue in full force and effect.

**ENTIRE AGREEMENT:** This contract constitutes the entire agreement between the parties and supersedes any prior understanding or representation of any kind preceding the date of this contract. This contract may be modified in writing but must be signed by both Turning Point and the Owner.
